Alfred Turner of South Carolina, Greenville District, doth hereby certify that I, Alfred Turner of Greenville District & State aforesaid for & in consideration of the sum of One hundred & thirty three dollars to me paid by Hinson Middleton of Anderson County in the State of North Carolina have granted bargained sold & released & by these presents do grant bargain sell & release unto the said Hinson Middleton, a part of a certain tract of land containing one hundred acres more or less, lying on the North side of the Meadow Fork of Muske Creek and bounded as follows: Beginning on a Spanish oak corner on the Creek thence a straight line to a Post oak corner on the Ridge path thence south along said path to a white oak corner thence a straight line to a post oak, thence a straight line to the mouth of a branch where it enters into the Creek, thence up the Creek to the Spanish oak corner. Together with all & singular, the rights, members, hereditaments and appurtenance, to the said premises belonging or in any wise incident or appertaining. To have and to hold, all and singular the premises unto the said Hinson Middleton, his heirs and assigns forever. I do hereby bind myself my heirs, executors and administrators to warrant & ever defend all and singular the said premises unto the said Hinson Middleton his heirs & assigns and against myself & my heirs & against every other person whomsoever lawfully claiming or to claim any part thereof. Witness my hand & seal this the 8th day of Nov'r in the year of our Lord one thousand eight hundred forty one, signed sealed and delivered in the presence of, Test,
