

Superintendent of Public Works of the State aforesaid, of the one part, and James M. Bailey, of the other part:

Whereas, The said James M. Bailey stands indebted to the said John M. Leland Superintendent as aforesaid by Bonds for the sum of twenty-nine dollars and forty-one cents payable in three annual instalments, with interest from the date thereof, That is to say, one third part with interest, on the seventeenth day of July, 1845, one other third part, with interest, on the seventeenth day of July, 1846, and the remaining third part, with interest, on the seventeenth July, 1847.

Now this Indenture witnesseth, That the said James M. Bailey for and in consideration of the said debt or sum, payable as aforesaid, to the said John M. Leland, Superintendent as aforesaid, and for the better securing the payment thereof, to the said John M. Leland, Superintendent aforesaid, and also in consideration of the sum of One Dollar by him the said John M. Leland Superintendent as aforesaid to the said James M. Bailey in hand paid at and before the sealing and delivery of these presents, do Grant, Bargain, Sell, Convey, Release, Quitclaim unto the said John M. Leland and to his Successors in office, or Assigns, forever all that tract or parcel of land situated in Greenwill District in waters of South Tigr River, containing twenty-six and a half acres, more or less, said tract was surveyed as Vacant Land for Robert Langford the 24<sup>th</sup> September, 1834, Together with all and singular the Rights, Members and Appurtenances thereto belonging, or in any wise appertaining, and the Reversion and Reversions, Remainder and Remainders, Rents, Issues and Profits thereof, to have and to hold, the said tracts of land, with the appurtenances, unto the said John M. Leland, his Successors in office, or assigns forever.

Provided always nevertheless, and it is the true intent and meaning of the parties to these presents, that if the said James M. Bailey, his heirs, executors or administrators, shall well and truly pay or cause to be paid unto the said John M. Leland his Successors in office or assigns, the sum of twenty-nine dollars and forty-one cents according to the Bonds above mentioned, then and from thenceforth these presents shall be utterly null and void, any thing herein contained to the contrary thereof in any wise notwithstanding. And it is covenanted and agreed upon, by and between the parties to these presents, that until default shall be made in payment of the aforesaid sum, as before set forth, and the interest for the same, it shall and may be lawful to and for the said James M. Bailey peaceably and quietly to hold, use, occupy, possess and enjoy all and singular the premises above granted and released, and every part thereof, with the appurtenances, and to have, receive, and take the rents, issues and profits, to his own particular use and behoof, any thing herein contained to the contrary hereof in any wise notwithstanding.
