Now all men by these presents that We, Isaac Roberts and Elizabeth Roberts his wife, both of the County of Murray in the State of Georgia, for and in consideration of the sum of Five Hundred Dollars to us paid, the receipt whereof we do here by acknowledge, by James Pickett of Greenville District in the State first above mentioned, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James Pickett, a certain tract or parcel of land containing One hundred and ninety-five Acres situate in the said district of Greenville in the aforesaid State of South Carolina, on the banks of the Reedy Fork of Reedy River, it being part of a tract of land originally granted to adjoining land of said Pickett, George Croft, William Curson, and lands of a free black by the name of Ellicker. It being also the same tract of land conveyed by Lee to the said Isaac Roberts
