Title Deed. Release of House
 & Lot on Rutherford Road.

The State of South Carolina, Whereas
 Greenville District. Edward

Croft of Greenville District, in the state aforesaid, has, for some considerable time, now past, advanced in various ways, for the use, benefit & service, of Mrs. Sarah D'Orley & Mrs. Sarah Baker, & for the use of their children & negroes, the negroes settled on Mrs. D'Orley and her children, the Trust Estate, the sum of Two hundred & twenty-five dollars, all expended and laid out in the actual support, maintenance & wants of the above named Mrs. D'Orley, and her children, & also negroes settled on them - and at their instance and request - and whereas, neither the said parties or the trust Estate is able to pay to the said Edward Croft, his just debt, so advanced as aforesaid - And whereas, the House & Lot, on the Rutherford Road, containing one acre and one fourth, or thereabouts, be the same more or less, in the State & district aforesaid - is now in a ruined & dilapidated condition; & of little, or no profit to the Trust Estate, & whereas it is deemed judicious & proper to sell the said House & Lot to the said Edward Croft for the payment of the sum so advanced by him as aforesaid - Now know all men by these Presents; that Mr. Sarah Baker & Sarah D'Orley, for and in consideration of the above set forth premises; and also in consideration of five dollars to us in hand paid, the receipt whereof is hereby acknowledged, have granted & bargained, & by these presents do grant, bargain & sell unto the sd Edward Croft & his Heirs forever - All that piece of Land, lying and being on the Rutherford Road, now in the occupation of Madison Reiner, containing about one acre & one fourth a thereabouts, be the same more or less, to have & to hold the said Lot of Land, Together with all & singular the appurtenances thereto belonging) or incident in any wise; to him & his Heirs, forever - And we do hereby bind ourselves & our Heirs forever, to warrant & defend the same to him & his Heirs - for & against ourselves & our heirs, & every person, or persons whomsoever claiming as to claim the same or any part thereof, the said lot of Land, situated & being on the Rutherford road, butting & bounding, on the North by lands late of The Estate of Carl, on the West by lands of Elias Carl, on the East by lands of David Long & on the South by lands of Edw^r Croft, containing one acre & a quarter be the same more or less to have & to hold all & singular the premises intended to be bargained sold & released, unto the said Edward Croft & his Heirs for ever.
