Butters line, N. 87° W. 6.32 links to a small Post oak, thence N 53° E. 8.00 chains to the beginning - containing three acres, three woods and two pinches, more or less.

Together with all and singular the Rights, Members, Incumbents and Appurtenances to the said Premises before mentioned or in anywise incident or appertaining: To Have, and to Hold, all and singular the Premises before mentioned, unto the said Thomas Pickens Buttes his Heirs and assigns forever. And I do hereby bind myself, my Heirs, Executors and administrators to warrant and forever defend, all and singular the said Premises, unto the said Thomas P. Buttes, his Heirs and assigns, against myself and my Heirs, and against every person whomsoever, lawfully claiming or to claim the same, or any part thereof.

E. a strait line to a small red oak thence N. W. a strait line to a rock thence N strait line to a sassafras then N. W. a strait line to a black Gum on a small branch thence down said branch to Fox Creek
