Staten of the district and State aforesaid and for his better preferment and also in consideration of the sum of Three Hundred Dollars to me in hand paid by my said son James R. Staten at and before the sealing and delivery hereof the receipt whereof I do hereby acknowledge have given granted bargained sold and delivered and by these presents do give grant bargain sell and deliver unto my sd son James R. Staten all the goods and chattels following to wit one negro girl Esther and child Roda Maneroa together with all my right title claim and interest in and to a lease on the river bottom of South Tyger river belonging to George Dill of the district and State aforesaid together with all rights titles increase claims interests or privileges arising from the same that is or may be due at any time whatsoever in fee simple for ever. To have and to hold all and singular hereby given and granted unto the sd James R. Staten my son his heirs Executors administrators for ever as his or their own proper goods & chattels In witness whereof I have hereunto set my hand & seal this 27<sup>th</sup> day of March 1847.

Sullivans Land at the Creek thence along Sullivans line & Susan Chandlers line to a post oak Corner bounding on Clem Trenchmans line to a small Muscogee Corner
