Henry Stokes (the receipt whereof is hereby acknowledged) have given, granted, Bargained, sold and released and by these presents do give, grant Bargain sell and release unto the said T. Henry Stokes all that tract and parcel of Land situate and being in the District and State aforesaid lying and being on the waters of Gilders and Laurel Creekes, bounded by Lands of W^m Griffith John J. Stokes, Thomas Forester and Rev. Arthur. Beginning on a Post oak running thence S^o 30 W 65th 50 to a post oak, thence S^o 70 E 15th to a rock, thence N 68 E 54th to a Black jack, thence N 18 E 10th 50 to a white oak, thence N 51 W. 48th. to the beginning Containing two hundred and Eleven acres be the same more or less.

Also one other certain piece, parcel and tract of Land situate and being in the District and State aforesaid lying on the waters of Laurel Creek, bounded by lands of W^m Griffith John J. Stokes Elizabeth Paul Bowers Griffis Thomas Forester & the Land above conveyed - Beginning at Pine down, running thence N 58 W 30th 50 to Red oak, thence N 38 E 25. to a stake, formerly a pine thence N 28 W 25 to a stake thence S 80 E 59 to a stake, thence S 14 W 8 to a stake thence S 10 W 26. 40 to a red oak, thence N 47 W 21 to a Post Oak, thence S 27 W 30. 50 to the beginning containing Two hundred acres more or less. Henry Stokes his Heirs and assigns forever. And I do hereby bind myself my Heirs Executors and Administrators to warrant and forever defend all and singular the said premises unto the said T. Henry Stokes his Heirs and assigns against myself & my Heirs & against every person whomsoever lawfully claiming or to claim the same or any part thereof. — Witness my Hand and seal this the 22 day of November in the year of our Lord one Thousand Eight hundred and forty seven & in the Seventy second year of the independence of the United States of America.
