I, David Hooke Sheriff of Greenville

District and State aforesaid send greeting. Whereas by virtue of a Writ of Fine Fines issued out of the Court of Equity held for the District of Greenville tenth the day of October in the year of our Lord one thousand eight hundred and forty seven at the suit of Vandy Mcbee, to me directed commanding me that of the goods and chattels, lands and tenements of Andrew Lester, to pay the sum of Five hundred dollars and twenty five cents damage and costs. I have seized and taken of the lands and tenements of the said Andrew Lester, all that certain piece, parcel and tract of land containing One hundred and fifty six acres, situated and being in the District of Greenville adjoining lands of Mrs Lester and others And whereas the said promise with two appurtenances, since the seizure by me made by virtue of said Writ of fine fines before mentioned have been exposed to sale at public vendue and purchased by William P Mcbee of the District of Greenville for the sum of Fifty Dollars being the highest sum that has been bid therefor Now therefore I, That I, David Hooke Sheriff aforesaid by virtue of the said Writ of Fine Fines aforesaid to me directed and determined as aforesaid and by virtue of the Statute in such cases made and provided, and for and in consideration of the sum of Fifty Dollars to me in hand paid or secured to be paid by the said William P Mcbee the receipt whereof I do hereby acknowledge have granted, bargained, and sold, and by these presents do grant bargain and sell unto the said William P Mcbee his heirs and assigns forever, the said tract, piece or parcel of land with its appurtenances and all the Estate, right title and interest which the said Andrew Lester, of right had, of in and to the same

To have and to hold the said piece of land, and tract of land with its appurtenances unto the said William P Mcbee his heirs and assigns forever as fully and absolutely as I the said David Hooke might conceive ought to grant, bargain, and sell by virtue of the Statute aforesaid and the said Writ of Fine Fines or otherwise
