 these presents do grant, bargain, sell and release unto the said Springfield a certain  
 Tract or parcel of Land containing One Hundred acres situated lying and  
 being in the District of Greenville and State aforesaid On both sides of the road leading  
 from H C Lynch's plantation House to Spartanburgh C. H. on the North side of  
 Beaver dam excepting waters of Beaver river Beginning on a Stake 3x Thence S 45° E  
 to a Stake 3x Thence S 87° E 24 to a sweet gum Thence W to W 50 chain, to a  
 Holly 3x Thence N 66° W to a maple 3x South 40° W to the beginning  
 N 0. 3x Also another Tract a parcel of Land containing fifty six acres adjoining  
 the above Tract Beginning on a stake near Diana Ham Creek Thence up said creek  
 to a white Oak 87° W Thence N N 53 to a rock 3x Thence W 16° W 59 to a red oak  
 3x Thence E 19. 50 to a red oak 3x Thence S 40. 75 to the beginning corner
