and District aforesaid have Granted bargained sold and released and by these presents  
do grant bargain sell and release unto the said David McCulloch all that tract  
a parcel of land containing Two hundred and forty five acres more or less  
lying in the State and District aforesaid in the name of Golden Grove which  
said tract of Land is laid out to said David McCulloch as follows Beginning  
on a Stake 3x on the Spartanburgh road running S. 28<sup>th</sup> W. 39.00 ch to a Stake  
3x "Heams corner bounded by lands of David Hunter Thence South 11<sup>th</sup> W. 28.50  
chs to a Stake 3x bounded by Heams land Thence W. 45.00 37 chs to a White  
3x bounded by lands of H. Chapman Thence N. 30<sup>th</sup> W. 15.17 chains to a corner  
3x Thence N. 43<sup>th</sup> W. 10.40 ch to a Holly 3x " on a branch of the Golden Grove  
Thence up said Branch about 10 chs to a Beech 3x Thence N. 46<sup>th</sup> W. 7 chs to a  
Hickory 3x Thence N. 47<sup>th</sup> E. 30 chs to a Stake 3x bounded by lands of Wm. Th. Gar-
