Charleston S C Trustee of Mrs Eliza Simmons under the will of Thomas Wigfall deceased
in the State aforesaid have granted bargained sold and released and by these
presents do grant, bargain, sell and release unto the said Heating L Simmons
Trustee of Mrs Eliza Simmons as aforesaid All that piece of land and tract
of Land Situated lying and being in the District of Greenville and State of South
Carolina bounded on the South branch of Richland Creek waters of Reedy River adjoining Lands
of Dr John Wittenow P G Gerard Estate of Pinckney Hawkins Mrs E
Rouland and others containing One hundred and twenty three acres (123) more or
less and bounded as follows Beginning at a small white oak 3x on the road
leading to Pinckney Hawkins late residence along the old road to a
Porkoak near the said Pinckney Hawkins late residence Thence S 11 E
10.65 chains to a Black Oak 3x Thence S 16 E 22.75 to a chestnut 3x Thence
S 22 E 26.50 to a Hickory 3x Thence due E 3.70 to a Hickory 3x Thence N 40 E
across the creek 23.87 to a Post oak 3x Thence N 46 W 7 to a stake on the bank
in the field Thence N 4 E 32.42 to the beginning being the same tract of Land
which was sold by partition among the heirs of Thomas Allen blood of Colvin
Watson Ordinary of Greenville District to Rodger Sandland and by him sold
and conveyed to me by deed bearing date the 21st May 1836

To have and to hold the same in Trust for Mrs Eliza
Simmons aforesaid and for the use and benefit in accordance with the pur-
poses and intent of her appointment as Trustee under the will of Thomas
Wigfall deceased

-doments and Appurtenances to the said premises belonging or in anywise
incident or appertaining To have and to hold all and singular the said
Premises before mentioned unto the said Heating L Simmons Trustee
as aforesaid his heirs and assigns forever And I do hereby bind myself
my Heirs Executors and Administrators to warrant and forever defend
all and singular the said Premises unto the said Heating L Simmons
Trustee as aforesaid his heirs and assigns against me and my Heirs
and against every person whomsoever lawfully claiming or to claim the same
a copy shall stand
