and for divers good causes and considerations as hereunto moving have made order  
and appointed and by these presents do make certain and appoint Miles Southern  
of the State of South Carolina and District of Greenville our true and lawful attorney  
in fact for us and in our name and for our use and benefit to proceed to the State  
of South Carolina and District of Greenville aforesaid and to ask for and demand  
and receive of and from Thomas P Butler the Commissioner in Equity of the Court  
of Equity for said District and also of Wilson S Crowder Administrator of all  
our singular the good and chattels, lands and Tenements or otherwise of Wsa  
Crowder late of said District deceased all our distributive share or shares, leg-  
acies or Legacies or other rights or interests whatsoever in the estate of the said Wsa  
Crowder deceased consisting of money, goods, chattels, lands and Tenements or  
otherwise whatsoever which would have been due to the said Septima Crowder if  
she had then remained single and unmarried And to have use and take all  
lawful way and means in any manner or otherwise that may be found necessary  
or proper in the execution of this power of Attorney To execute all such deeds in our  
names that may be necessary and proper for the purposes aforesaid And do all other  
acts and things whatsoever concerning the premises as fully in every respect as we  
ourselves might or could do were we personally present at the doing thereof and we  
do now attorney under him for the purposes aforesaid to make and again at his  
pleasure to make, Ratifying and confirming and by these presents attaining whatsoever  
the said Attorney shall in our names lawfully do or cause to be done in and about  
the premises by virtue of these presents
