Reedy Fork on Reedy River Containing One Hundred and Forty Acres to the
same more or less and bounded by lines belonging to Sosiah Chandler Mordie
Mc Smith Wilson Tollison and George Smith and Adam Jones

Together with all and singular the rights members hereditaments
and appurtenances to the said premises belonging or in anywise incident appertaining

To have and to hold all and singular the premises herein mentioned
unto the said Davy Hopkins his heirs and assigns forever And I do hereby bind
myself my heirs Executors and Administrators to warrant and forever defend all and
singular the said premises unto the said Davy Hopkins his heirs and assigns against
myself and against every person whomsoever lawfully claiming or to claim the same
or any part thereof Witness my Hand and Seal this 30th of September in the
year of Our Lord One Thousand Eight Hundred and Forty eight and in the second
year of the Independence of the United States of America
