Peter Gamble To Nancy Hughes	688 of Gift	South Carolina } Know all men by these Greenville District } presents that for and in consideration to me in hand paid of the sum of one dollar paid by Nancy Hughes of the State and District aforesaid and for the love and affection that I have for the said Nancy Hughes I do hereby deed to her the following property by an Iron Rod of said State of my and being in the District aforesaid commencing on the south side of the Branch near the school house spring on a red oak and running up the North Side of the Branch to Moses Stony Land Thence NE to the corner of the said Nancy Hughes land Thence in easterly direction to a Post Oak corner Thence to the beginning containing early acres more or less Also four negroes by name Daniel, Tom, Simeon & Smith one grey Horse one bay mare two new red saddle and bridles seven head of cattle Ten hogs forty fowling Two sows and pigs Three beds, bedsteads and furniture one half of all my plantation tools one half of all my provisions on my place to enable her to make a crop and one half of the crop when made one half of the flock of sheep one half of the wagon and harness one cup and one half of the crockery and contents 345 all of which property I do hereby deed to the said Nancy Hughes and warrant and forever defend the same to her to her heirs Executors Admors &c and I do hereby bind myself my heirs Exors Admors to warrant and defend the said title against myself by their Exors Admors &c
