kin of the other part, Akin & Re said Mr. Morgan to and by a certain, willing obligator under seal and seal bearing certificate herewith the goods bound, unto the said James M. Makin in the sum of Five hundred and fifty one dollars 59 cents on the 8th day of January with lawful interest at the same as in any case of obligation and condition there being this unto, to pay my agent at large aforesaid. Now this indenture witnesseth that the said Mr. Morgan as aforesaid in consideration of the aforesaid debt of sum of five hundred and fifty one dollars and fifty nine cents for the better securing the payment thereof with interest due to the said James M. Makin his executors administrators and assigns, do offer and give the sum of one dollar by him on hand paid by the said James M. Makin at and before the signing and delivery hereof the receipt whereof is hereby acknowledged, hath granted, bargained, sold released and confirmed, away by these presents, and again sell released and confirm, unto the said James M. Makin his heirs and assigns all that messaged or two tracts of land lying on both sides of Mill Creek, whereof tract Morgan goes to the W. N. E. direction, containing 439^{1/2} acres, thence N. 56° 65' E. 108^{1/2} to R. C. thence S. 85° 44' E. 108^{1/2} to a stake & 13 M. 40 chs to R. C. thence S. 11° 40' E. 108^{1/2} to stake, thence N. 68° 00' W. 108^{1/2} to stake, thence S. 10° 45' E. 108^{1/2} to stake, thence S. 88° 14' E. to pine tree, & so to R. C. thence N. 10° 16' E. 108^{1/2} to a pine, thence S. 88° 16' E. 108^{1/2} to a stake, thence S. 71° E. 2^{1/2} rods to stake, thence N. 10° E. 58 chs to the west, thence N. 73° E. 15 chs to a chestnut, thence S. 40° E. 26 chs to a pine thence N. 31° E. 30 chs to the beginning pine, containing two hundred and seventy six acres more or less. The other tract adjoining same beginning on a R. C. oak on a line running N. 36° E. 58 chs S. 108^{1/2} chs to R. C. thence S. 56° E. 45 chs to R. Makin his heirs, executors administrators or assigns the aforesaid debt or sum of Five hundred and fifty one dollars and 59 cents on the day and time herein before mentioned and appointed for payment thereof with lawful interest for the same according to the condition of the said recited obligation without any fraud or further delay and without any deduction, depreciation, or abatement to be made of anything for or in any respect of taxes charges or rates whatsoever, then by this indenture the estate hereby granted shall cease and become absolutely null and void.
