of our said State Greeting Whereas we the said Augustus Anderson & C. S. Holstein in and by our certain Bond or obligation bearing even date with these presents stand firmly held & bound unto Thomas S Arthur in the sum of twelve hundred and fifty four dollars conditioned for the payment of the full and just sum of six hundred and forty seven dollars (\$647) in two equal annual instalments as follows viz Two hundred nine dollars on the first of January 1857 Two hundred and nine dollars on the first of January 1857 and Two hundred and nine dollars on the first of January 1858 with legal interest from date payable annually as in and by the said Bond & conditions being thereunto had and now fully appear Now know all men that we the said A. Anderson & C. S. Holstein in consideration of the said debt and sum of money above said for the better securing the payment thereof to the said Thos S Arthur according to the conditions of the said Bond also in consideration of the further sum of three dollars to us the said A. Anderson & C. S. Holstein in hand paid by the said Thomas S Arthur as before the sealing & delivering whereof presents the receipt hereof is hereby acknowledged that we the said A. Anderson & C. S. Holstein have granted sold and conveyed & by these presents do grant bargain & sell and convey unto the said Thos S Arthur all that piece of Land situate lying & being in the District of Greenville & State of our said containing one hundred and fifty four & half acres more or less which is described in a deed of conveyance of the same from Archibald League to Thomas S Arthur dated the 2d of May 1849 as follows that is to say all that tract or parcel of Land situate in the District of Greenville Dist & State of our said containing one hundred and fifty four & half acres more or less formerly belonging to William Griffith and bounded by lands belonging Stokes Scargin & others which has been conveyed by a deed from the said Thomas S Arthur to us the said A. Anderson & C. S. Holstein of our date with these presents

Together with all and singular the rights, members & appendages & appurtenances to the said premises belonging or in any wise incident or appertaining

I have and to hold all and singular the said premises unto the said Thomas S Arthur this day and assigns forever And we the said Augustus Anderson and C. S. Holstein do hereby bind ourselves & each and every of our heirs executors jointly & severally to warrant and forever defend all and singular the said premises unto the said Thomas S Arthur this day and assigns forever from and against us & our heirs Exec. admt & aginst all other persons in due & lawfully claiming w^to claim the same or any part thereof.

If soever always lawfully and it is the true intent & meaning of the parties to these presents that if the said Augustus Anderson & C. S. Holstein doth well and truly pay or cause to be paid unto the said Thos S Arthur the said debt or sum of money aforesaid
