Together with all and singular the rights members hereditaments and appurtenances thereto belonging. aforesaid for and in consideration of the three hundred Dollars to me in hand paid by Philip C Lester of State and district aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Philip C Lester all that tract or parcel of Land situate and being in the State and district aforesaid and laying around the natural dam shoal on Rocky Creek waters of Enone river and on the eastern bank of said Creek containing three acres more or less and bounded as follows begining on Post oak ³ at a bend of the said creek above said natural dam shoal near the waters edge and running S $\frac{1}{2}$ E 66.50 six chains and fifty links to a Stake ³ thence S 16 $\frac{1}{2}$ E 41 four chains to a Stake ³ thence S 89 E 8.10 three chains ten links to a Stake ³ thence S 80 E 3.50 three chains and fifty links to a Stake ³ thence due East 3.50 three chains and fifty links to a Stake ³ thence S 33 E 5.40 five chains and forty links to a Stake ³ thence N 60 W 2.32 two chains and thirty two chains to a Spring though the middle of said Spring down meanderings of Spring branch to the Creek thence up the meanderings of the said Rocky Creek to the begining.
