 To For I know all men by these presents
 I Ralph Smith Land that I John S Willbanks in the
 State aforesaid for and in consider-

ation of the sum of Two Thousand Dollars to me paid by
 of Ralph Smith in the State aforesaid have granted bargained sold and released and by these presents do grant
 bargain sell and release unto the said of Ralph Smith
 all that piece parcel and lot of Land situate lying and
 being within the corporate limits of the Town of Greenville near
 the G & C H Road Depot having the following boundaries & corners
 Viz. beginning at a Stake 3⁺ on the Pendleton Road and running
 thence with said road one hundred feet to a Stake 3⁺ thence with
 Lot No 2 Four Hundred & Thirty three feet to a Stake 3⁺ on
 a Street or lane 30 feet wide, thence with said Street or
 lane until it intersects a Street 50 ft wide thence with said
 Street until it intersects Lot No 4 and thence with Lot
 No 4 to the beginning corner being the same lot of Land
 conveyed to me by Thomas C Gower and Henry C Marksley
 by Deed of 18th June A D 1860. Together with all and singular
 the rights members hereditaments and appurtenances to the
 said premises belonging or in any wise incident or appertaining
 to them and to hold all and singular the premises before before
 mentioned unto the said of Ralph Smith his heirs and assigns
 forever, and I do hereby bind myself my heirs executors and
 administrators to warrant and forever defend all and singular the
 said premises unto the said of Ralph Smith his heirs and assigns
 against me and my heirs & any person or persons whomsoever
 lawfully claiming or to claim the same or any part thereof

 sixth year of the Sovereignty and Independence of State South Carolina
