that I David Anderson of the
 State aforesaid and District of Spartanburg Executor
 of the last will and Testament of Thomas P Brockman
 deceased by Virtue of authority in me vested by the last
 will and testament of Thomas P Brockman deceased
 and for and in consideration of the sum of Four Thousand
 and fifty Dollars to me in hand paid at or before the
 sealing and delivery of these presents. the receipt whereof
 is hereby acknowledged have granted bargained sold con-
 ceded & confirmed and by these presents do grant bargain
 sell convey & confirm unto Julius R Earle his heirs and
 assigns forever, all that tract or parcel of Land situate
 lying and being in the State and District above named
 on Enoree River known as the place wheran Thos P Brock-
 man formerly lived bettering and bounded as follows, begining
 at the west end of Brockmans bridge on Enoree River
 and running thence with the road S68 $\frac{1}{2}$ W 2.33 to a bend
 in the road, thence with the said road S28 W 9.50 to a bend in
 the road thence with the road S37 $\frac{1}{2}$ W 9.50 to where the road
 crosses the branch, thence up the meanderings of said branch
 7 chains to an Ash tree thence with the Farmers line N65 E 8 ch to
 a H 0 3 & said lines corner thence with Snows Line S28 W 30.50 to
 a Post oak 3 & thence S57 $\frac{1}{2}$ E 19.00 to a Post oak 3 & thence S41 W 27.50
 to a Spanish oak 3 & thence S54 $\frac{1}{2}$ W 12.50 to a hickory stump on the factory
 road thence S47 $\frac{1}{2}$ E 96.25 to a Post oak down, 3 & thence N18 E 17.00 to a
 white oak down, on a branch, 3 & thence down the branch 43 chains to
