State aforesaid for an inconsideration of the sum of Five Hundred and fifty dollars in hand paid by L D McMakin of Greenville District and State aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said L D McMakin a tract or parcel of Land situate lying and being in Greenville District and State aforesaid on the south side of Middle Tyger River bounded as follows by lands of L H Dickey Shadrick Crane and Joseph McKinney beginning at a Stake in the middle of Tyger River and runs S 8 E 8, 25 to a Persimmon & thence S 38 1/2 E 20.50 to a Rock thence running with the road to the Glassy Mountain Meeting house to ford of the River thence down the river to the beginning corner containing. Forty one and three fourth Acres be the same more or less together with all and singular the rights members hereditament and appurtenances to the said premises belonging or in anywise incident or pertaining. To have and to hold all and singular the premises before mentioned unto the said L D McMakin his heirs and assigns forever, and we do hereby bind ourselves and our heirs executors and administrators to warrant and forever defend All and singular the said premises unto the said L D McMakin his heirs and assigns forever, against our heirs and against every other person or persons lawfully claiming or to claim the same or any part thereof.
