Ivines lot and runs thence S³ 3¹/₄ W 180 feet to a Stake ³⁺ thence North 55¹/₄ W 244 feet to a Stake ³⁺ thence N 18 E 105 feet to a Stake ³⁺ lower corner of said Ivines lot thence with Ivines line S 72 E 283¹/₂ feet to the beginning corner containing a fraction over three quarters of an acre more or less. Together with all and singular the rights members hereditaments and appurtenances to said premises belonging or in any way incident or appertaining. To have and to hold all and singular the premises before mentioned unto the said Jonah M Vening his heirs and assigns forever and I do hereby bind myself and my heirs to warrant and forever defend all the premises before mentioned to the said Jonah M Vening his heirs executors administrators and against the claims of any person whomsoever lawfully claiming or to claim the same or any part thereof.
