sold and released unto the said Jacob Reece all that piece  
parcel of land lying on the North Reedy Fork in the District aforesaid  
being a part of the James Kiett place containing One hundred and  
thirteen acres more or less beginning at stone & corner thence N 77.815.  
Red oak & thence S 77.834 E Stake thence N 66.84.85 Stone formerly Red oak &  
thence N 18<sup>o</sup> 45' W 27.90 Stone & thence N 89. W 37.40 Pine Root & thence S 20 W 16.10  
Black Gum & thence South 10 to the begining corner, Together with all and  
singular the rights members hereditaments and appurtenances to the said  
premises belonging or in any wise incident or appertaining to have and  
to hold all and singular the premises before mentioned unto the said  
Jacob Reece his heirs and assigns forever and I do hereby bind my  
self my heirs executors and administrators to warrant and forever  
defend the said premises unto the said Jacob Reece his heirs and  
assigns against my self and my heirs and against every other person  
or persons whosoever lawfully claiming or to claim the same or any  
part thereof
