 that I James L Hudson of the

District and State aforesaid for and in consideration of
 the sum of Two Thous and five Hundred dollars to me
 in hand paid by Thomas A Hootyclaw of the District and
 State aforesaid the receipt whereof I do hereby acknowledge
 have granted bargained sold and released and by these
 presents do grant bargain sell and release unto the said
 Thomas A Hootyclaw all that tract or parcell of Land situate
 lying and being in the District and State aforesaid on the
 waters of Rocky Creek waters of Enoree River adjoining
 lands of W Riley Smith J D Smith Wiley King Matthew Hudson
 - son and others begining on a sweet gum 3+ on Rocky Creek
 and running thence N 12 W 33.75 chs to a Red oak 3+ thence N
 81 West 9.50 chs to a post oak 3+ thence N 65 W 9.50 chs to a
 Red Oak 3+ thence N 61 W 11.00 to a stone 3+ thence S 54 $\frac{1}{4}$ W 29.58
 chs to a Hickay 3+ thence S 23 $\frac{1}{4}$ E 10.76 chs to a stone 3+ thence
 S 38 E 17.44 chs to a Pine 3+ thence S 50 E 12.06 chs to white oak 3+
 on the Bank of the said Rocky Creek thence down the
 meanderings of the said Creek to the Beginning and which is
 more fully shown by a Plat hereto attached containing
 One hundred and eighty four and one half acres with
 the exception of one half acre around the grave yard
 where my Father Jno W Hudson was buried the same being
 more or less. Together with all and singular rights members
 hereditaments and appurtenances to the said premises belonging
 or in anywise incident or appertaining. To have and to hold
 all and singular the premises before mentioned unto the said
 Thomas A Hootyclaw his heirs and assigns forever and I do
 hereby bind my self my heirs executors and administrators to
 warrant and forever defend all and singular the premises
 before mentioned unto the said Thomas A Hootyclaw his heirs
 and assigns against my self and my heirs and against
 every other person or persons whomsoever lawfully claiming
 or to claim the same or any part thereof.
