 To For Know all men by these presents  
 Susan Ellis Land that I R B Duncan of Greenville  
 District in the State aforesaid in

consideration of the sum of Eight Hundred and Sixty  
 eight Dollars to me paid by Susan Ellis of Anderson  
 District in the State aforesaid have granted bargained  
 sold and released and by these presents do grant bargain  
 sell and release unto the said Susan Ellis all that tract  
 or parcel of land lying in the District of Greenville and  
 State aforesaid on Saluda River beginning at a corner on  
 the bank of the said River near the mouth of a small branch  
 and running N 4 W 36 chs & 80 links to a small persimmon tree  
 on the old road to Stanton's bridge. Thence N 66 E 13 chs 15 links  
 to a Stake 34 thence S 42 1/2 E 44 chs to a Stake 3+0 being a long  
 Aaron Thompson's line. Thence S 58 W 63 7 chs 50 links along L Leach  
 - ard's line to a Sweet Gum 34 0 m on the bank of the Saluda  
 River. Thence up the said River with all its meanderings  
 to the beginning as exhibited by a plat hereunto annexed  
 containing One hundred & twenty four acres more or less being  
 part of a tract of land sold by Mr & Mrs Payne to the Hon  
 Richard Gant & part of a tract sold to the same by  
 John Tripp. Together with all and singular the rights members  
 hereditaments and appurtenances to the said premises belonging  
 or in anywise incident or appertaining. To have and to hold  
 all and singular the premises before mentioned unto the said  
 Susan Ellis her heirs and assigns forever and I do hereby bind  
 my self my heirs executors and administrators to warrant and  
 forever defend all and singular the said premises unto the said  
 Susan Ellis her heirs and assigns against my self and my heirs  
 or any other person or persons lawfully claiming or to claim the  
 same or any part thereof.
