McBee in the State aforesaid have granted bargained sold
and released and by these presents do grant bargain sell
and released unto the said Susan R B McBee all that tract
or parcel of land situated in the village of Greenville State
aforesaid lying on West Street beginning at a Stake 3rd corner
on west Street & running with W R B Farms line S 22. W 99.
feet to a Stake corner 3rd on Farms corner thence with said Farms
line S 50¹/₂ E 99. feet to a Stake corner 3rd on Farms line thence S 22.
W 76 feet to a Stake corner on Farms line thence N 67 W 17. feet
to a Stake corner and corner of a lot sold to W J Shumate thence
with W J Shumates line N 23. E 200. feet to a Stake 3rd thence S 67 E
with west Street 76¹/₂ feet to the begining corner containing 56
th of an acre be the same more or less being the lot conveyed
to me by Thomas R B Roberts Deed bearing date the 31st day
of January 1860 on which lot of land there is a cottage and
out buildings together with all and singular the rights more
less hereditaments and appurtenances to the said premises
belonging or in anywise incident or appertaining. To have

claiming or to claim the same or any part thereof
