 of the sum of Two thousand Dollars to me paid by Thaddeus
 C Bolling of District of Greenville in the State aforesaid
 have granted bargained sold and released and by these presents
 do grant bargain sell and release unto the said Thaddeus C
 Bolling all that Lot or parcel of Land situate lying and being
 in Greenville District and State aforesaid on the western Side
 of the Rutherford Road about one and a half miles from Greenville
 Court House containing Ten acres and twenty perches more or less
 commencing at a Stake corner of G W Green's Land and running
 thence N 45° 24' chs to a Stake on Mrs Rowlands line, thence South
 65° E 26' chs to the Rutherford Road thence S 25° E 7' chs 80 links along
 said road to a Stake thence N 65° W 27.25 to the begining corner
 & hath such plan and marks as a plat of the same made by W P
 McKee attached to the deed from Emily Rowland to Henry Mc Earle
 made the fourth day of November in the year of our Lord one
 thousand eight hundred and fifty represents. Together with
 all and singular the rights Members hereditaments and
 appurtenances to the said premises belonging or in any
 wise incident or appertaining. To have and to hold all
 and singular the premises unto the said Thaddeus C
 Bolling his heirs and assigns forever. And I do hereby
 bind myself my heirs executors and administrators to war-
