bargained sold and released and by these presents do grant  
bargain sell and release unto the said Elizabeth M Ayson all  
that lot or parcel of land situated in the town of Greenville State  
aforesaid on the Augusta Road begining at a Stake now Miss  
Wards formerly Herring Williams corner on the Augusta Road  
& running thence North 31° E 138 1/4 feet one hundred & thirty eight & one forth  
feet to a Stake & corner on a street leading to Furman University  
buildings, thence along said Street S 57 1/2 E to a Stake three hundred  
& thirty one feet to a Stake & thence South 37 1/2 West One hundred  
& Sixteen feet to a Stake & thence with the line of said Miss Wards  
N 55 1/4 W to the begining containing three rods more or less &  
being the same lot conveyed by deed of V McKee to Mrs Elizabeth  
Gridley, Together with all and singular the rights members
