

Wm M Thomas C & G 910 Deed The State of South Carolina
 To For
 S of Goodlett Land

This Indenture made the seventh day of December in the year of our Lord one thousand eight hundred and sixty three between William M Thomas Esqr Commissioner of the Honourable Court of Equity for Greenville District at Greenville Court House in the said State of the one part and Sandy J Goodlett of the other part Whereas Elizabeth Cantrell widow and others on or about the fourth day of April in the year of our Lord one thousand eight hundred and sixty three exhibited their bill of complaint in the court of Equity at Greenville Court House in the said State against Wiley Barton and others for the partition of the real estate of Alfred Cantrell deceased and the cause being at issue before the Honourable Court came on to be heard at Chambers Term in the year of our Lord one thousand eight hundred and sixty three when the said Court after full hearing thereof and mature deliberation in the premises did order adjudge and decree that said Real Estate should be sold at Public Auction, by the Commissioner of the said Court on the terms and for the purposes mentioned in their decretal Order as by reference thereto in the registry of the said Court will appear, and the said William M Thomas as Commissioner of the said Court after having duly advertised the said Real Estate for sale by Public outcry on the seventh day of December in the year of our Lord one thousand eight hundred and sixty three did then openly and publicly and according to the custom of Auction sell and dispose of the said Land below described unto the said Sandy J Goodlett for seven thousand five hundred dollars being at that price, the highest bidder for the same.
