 -ris as will more fully appear by said Morris deed to them
 bearing date the 21st day of December A D 1860. The said tract of land
 containing three hundred acres more or less and the said three
 fifth thereof being purchased jointly by the said George N Green
 and Willis M Green as share and share alike, and whereas the
 said George N Green recently departed this life intestate and
 leaving no wife or child or lineal descendant but leaving his
 father Danias Green his two Brothers Willis M Green and James
 Franklin Green and his two sisters Elizabeth Ross wife of Jesse
 Ross and Nancy M Brown wife of Israel H Brown as his only
 heirs and distributees at law, and whereas we James Franklin
 Green Jesse Ross and Elizabeth Ross his wife Israel H Brown and
 Nancy M Brown his wife have bargained and sold our respective
 shares of the aforesaid three fifths of said land to Willis M Green
 Therefore know all men by these presents that we James Franklin
