One hundred and twelve acres more or less situate lying and being
in State and his aforesaid on the East side of Laurel Creek waters of
Rudy River beginning on Poplar on said creek thence running with Betsy
McDaniels line N 85 E 16 chs to an oak corner now dead thence on Stokes
line N 28 E 34 1/2 chs to a Rock originally a pine thence N 88 W 36 chs to Rock
originally a pine this being and old line thence with the old line S 40
W 8 chs 72 L to a small white oak on said line then leaving the old line
South 13 ch to a black gum now dead then S 30 E 2 chs 50 L to a pine
stump thence S 32 E 3 chs 50 L to a Black Jack 3 prong thence long an old road
to the Mill thence South 2 chs to a Spring thence S 32 E 1 ch 70 L to a
Persimmon corner thence N 10 E 3 chs 50 L to a rock at a branch thence
