This indenture made the Fifth
day of March in the year of our
Lord one thousand eight hundred
and sixty three between William

M Thomas Esquire Commissioner of the Honorable Court of Equity
for Greenville District at Greenville Court House in the said
State of the one part and Martha Bridges of the other part
~~Witnesses~~ Martha Bridges and William M Thomas administrators
of the goods and chattels rights and credits which were of Moses
Bridges deceased on or about the Twenty seventh day of February
in the year of our Lord one thousand eight hundred and sixty
three exhibited their Bill of Complaint in the court of Equity at
Greenville Court House in the State aforesaid against William
Robert Bridges a minor for the petition of the seal estate of Moses
Bridges deceased. And the cause being at issue before the
Honorable Court came on to be heard at Chambers Term in the
year of our Lord one thousand eight hundred and sixty three when
the said Court after full hearing thereof, and mature deliberation
in the premises did order adjudge and decree that said land
should be vested in the said Martha Bridges for one thousand
and forty dollars being the appraised value of the land by the
Commissioner Partition. Now therefore this Indenture witnesseth that
the said William M Thomas as Commissioner of the said Court under
and by virtue of the said Decree and in consideration of the sum of
three dollars paid him by the said Martha Bridges the receipt
whereof is hereby acknowledged hath granted bargained sold and
released and by these presents doth grant bargain sell and release
unto the said Martha Bridges and her heirs and assigns all that
tract or parcel of land situate lying and being in Greenville District
on waters of Reedy River adjoining lands of Bridges Mc Cauley and
others containing one hundred and twenty six acres being the land
of which Moses Bridges died seized and possessed, and according
to a plat of the same. Together with all and singular the heredi-
taments rights members and appurtenances whatsoever to the said
land belonging or in anywise appertaining, and the reversions and
remainders rents issues and profits thereof, and also all the estate
right title interest dower possession property benefit claim and
demand whatsoever both at law and Equity of the heirs and repres-
entatives of the said Moses Bridges and of the parties to this
suit. and of all other persons rightfully claiming or to claim the
same or any part thereof by from or under them or either of them
to have and to hold the said land with its hereditaments and
appurtenances unto the said Martha Bridges and her heirs
and assigns to have and their only proper use benefit and behoof
forever. I witness whereof the said William M Thomas as com-
missioner of the said Court under and by virtue of the said Decree
hath hereunto set his hand and the seal of the Court on the day and
