Together with all the rights titles members hereditaments appurtenances belonging to the same or in anywise incident or appertaining to to have and to hold all and singular the above described premises unto the said Jr Mc White his heirs executors administrators and assigns forever and I do hereby bind myself my heirs executors administrators & assigns to warrant & forever defend all and singular the said premises to the said Jr Mc White his heirs executors administrators and assigns and against my self my heirs executors administrators & assigns and against every other person or persons whosoever lawfully claiming or to claim the same or any part thereof.
