 To Greenville District  
 Andrew J Snyder for Land Know all men by these presents  
 that I William Enix Trustee of

Elizabeth Enix of the said State and District in consideration  
 of the sum of Forty Dollars to me paid by Andrew J Snyder of  
 said State and District have granted bargained sold and released  
 and by these presents do bargain sell and release unto the said  
 Andrew J Snyder all that tract and parcel of land lying &  
 being situate in the District aforesaid known and described as follows  
 To wit, beginning at a Poplar near a spring branch, and running  
 thence N 67 $\frac{1}{2}$  E 4 chs thence S 22 $\frac{1}{2}$ .5 ch to a Rock thence S 67 $\frac{1}{2}$ .4  
 ch to a rock on the O line thence N 22 $\frac{1}{2}$ .5 ch to the beginning  
 corner containing in all two acres to have and to hold all and  
 singular the premises before mentioned unto the said Andrew J.  
 Snyder or his assigns, together with free and unobstructed ingress  
 and egress to the same to the nearest public road, and I do  
 hereby bind myself my heirs executors administrators and the trust  
 enterprisers, to warrant and defend all and singular  
 the said premises unto the said Andrew J Snyder and his  
 assigns against myself my heirs and assigns as well as against  
 the said Elizabeth Enix and against every person whosoever  
 lawfully claiming or to claim the same, In trust, nevertheless  
 that the said Andrew J Snyder is to have and to hold the said  
 land and premises for the sole and separate use benefit and behoof  
 of Mrs Mary W Timison wife of Archer Timison and the heirs  
 of her body, and the same is to be entirely free and exempt from  
 all debts dues or any contract or liability whatsoever of the  
 said Archer Timison now and in all time to come, and it is  
 hereby further stipulated and agreed that said Andrew J Snyder  
 Trustee shall may at any and all times sell and dispose of said land  
 and with the proceeds of sale make other investments whenever he is  
 requested so to do in writing by the said Mr Mary W Timison.
