Crook at and before the sealing and delivery of these presents the receipt whereof is hereby acknowledged the said Sarah Heoke Crook by and with the property consent and approbation of the said William F. Lester her intended husband testified by his being a party to and signing and sealing of these presents doth grant, bargain, sell, transfer, assign and let over unto the said John M. Crook, all and singular the property and Estate, to which the said Sarah Heoke Crook is entitled under the last will and Testament of her grand father John Heoke deceased, and her late father Dr A. B. Crook deceased and of which the said Sarah Heoke Crook is possessed as aforesaid. To have and to hold all and singular the aforesaid property and Estate unto the said John M. Crook upon such trusts, nevertheless, and to and for such uses, intents and purposes as are herein after declared of and concerning the same, that is to say, In trust for the said Sarah Heoke Crook her Executors, Administrators and assigns until the solemnization of the said intended marriage and from and immediately after the solemnization thereof, In trust that the said John M. Crook do and shall permit and suffer the said Sarah Heoke Crook during the joint lives of herself and the said William F. Lester her intended husband to have the enjoyment, dispositions and management of all and singular the property before mentioned, so that the same shall not in any
