Beginning at a stake on Avenue Street then on N 16 East 5 chs 15 to a Stake on Washington Street thence S 14 E one chain 94 links to another Stake in said street S 16 W 5 chs 15 to a Stake on Avenue Street hence along said street N 79 W one chain 94 to the beginning. Together with all and singular the rights premises hereditaments and appurtenances to the said premises belonging or in any wise incident or pertaining. To have and to hold all and singular the premises before mentioned unto the said George Heldman his heirs and assigns forever and I do hereby bind myself & my assigns heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said George Heldman his heirs and assigns against me and my heirs and every other person whomsoever lawfully claiming or to claim the same or any part thereof.
