of the Real Estate hereinafter described and conveyed. Now this indenture  
witnesseth that the said Julius C. Smith for and in consideration of  
the premises of one said and also in consideration of the sum of Five dollars  
(\$5) by the said Sarah P. Allen in hand paid, at and before the sealing and  
delivery of these presents, have granted bargained sold and released, and by  
these presents, have granted, bargained, sold and released, and by these presents  
do grant bargain sell and release unto the said Sarah P. Allen

All that piece parcel and lot of land situate lying and being in the town  
of Greenville in said County and State and having the following lines & bounds  
to wit, beginning at a stake on Main Street Mrs. Griffiths  
Corner, and running thence with Main Street N. 16 1/2 E. Three  
Hundred and twenty five feet (325) to a stake on College  
Street thence with College Street N. 58. All Two Hundred  
and forty five and one half 245 1/2 to a stake on Laurens  
Street thence with Laurens Street S. 16 1/2 W. Two Hundred  
and twenty eight feet (228) to a stake on North Street  
thence S. 13 1/2 W. North Street one hundred & eighteen (118)  
feet to stake Mrs. Griffiths Corner thence N. 16 1/2 E.
