consideration of your integrity and shall full power  
in hereby given to you or to any two or more of you  
to take & execute up the execution of the and Remonstrance  
arisen from W. P. Passmore of the County of Pulaski  
and State of Arkansas to Mrs. Melhelmina Chapman of the  
County of Greenville and State of South Carolina dated  
the 1<sup>st</sup> day of October A.D. 1873 Conveying a certain  
house and lot or parcel of Land Situate lying and  
being in the County of Greenville in the State of South  
Carolina in waters of Richland Creek and on both  
sides of the road leading to Rutherford North Carolina  
and containing three (3) acres & one and a half acres  
more or less and bounded as follows Beginning  
at a Stake on Shadrack Thompson's line at the base of  
the Hill on the South side of the road Riving thence  
North 50 Chain 30 Ticks to a Stake near a Spring thence  
East 50 Ticks to a Stake thence N 5° 17' 6.50 to a Sweet-  
Gum near the road thence S 71° 11' 5 with the road to a  
chain on the old line 31 thence with the old line N 10° 36'  
to a P.O. 31 thence W 31 to a Stake thence S 30 W 45 to a Stake thence  
S 71 E 27.50 to a Stake 31 thence N 0 0' 0 to a Stake thence N 45°  
W 7.70 to a Parafax 31 thence S 40 E 5 to a Stake thence S 6°  
W 21.9 to a Stake thence S 25-E 13.50 to a Stake 31 thence S 3°  
E 15 to Shadrack Thompson line at the base of the Hill thence S 85°  
E 15 to the base of the Hill thence S 45-E 13.50 to a Stake  
thence N 55-E 2 to the Beginning. For their purpose you  
shall cause one of the Subscribing Witnesses of the said  
Deed to appear before you & having administered to him  
an oath or solemn affirmation according to the form  
of his religious persuasion that his affidavit is true  
you shall take under his hand an affidavit that he was  
personally present & saw W. P. Passmore sign said Deed  
the said Passmore for the uses & intents therein specified  
and that he and the other Subscribing Witness signed  
their names thereon as witnesses of the said Deed which  
affidavit authenticated under your hands you  
shall cause to sign and have certified under your  
hand & seal the execution of this warrant required  
the same by the oath of you before some officer  
who is authorized by the State of your State to  
administer the oath and whose official signature  
may be properly authenticated you shall carefully  
affix this warrant together with your proceedings  
thereon to the Clerk of the Court of Common  
Pleas and General Sessions for Greenville County  
in the State aforesaid to be laid before the Honorable
