J L Southern J ^r	Deed	The State of South Carolina To all to whom these shall come I J L Southern Sheriff of Greenville County and State aforesaid send Greeting Whereas by virtue of sundry writs of Fieri Facias issued out of the Court of Common Pleas held for the County of Greenville tested the twenty sixth day of March in the year of our Lord One thousand eight hundred and Sixty one at the suit of W H Goodlett and J D Goodlett Exors of B G Goodlett Deceased against Israel Charles Joel Charles John Charles and Parkdale Charles defendants to me directed commanding that of the goods Chattels lands and tenements of the above named Defendants Israel Charles et al to pay the sum of four thousand five hundred and ninety six Dollars damages and costs I have seized and taken of the lands and tenements of the said Israel Charles all that cer tain piece of Land containing thirty acres more or less situated and being in the County of Greenville in the State aforesaid adjoining lands of Mrs Edwin Ware & saddle Evans and others being the same wherow Mr Eskev now resides and known as the Mill Tract And whereas the said premises with their appurtenances since the seizure by me made by virtue of the said Writ of Fieri Facias before mentioned have been exposed to sale at public Auction or Vendue and purchased by Simeon Eskev of the County of Greenville in the State of South Carolina for the sum of One hundred and Sixty Seven Dollars being the highest sum that was bidden therefore Now Know ye that I John L Southern Sheriff aforesaid by virtue of Statute in such case made and provided and for and in consideration of the said sum of One hundred and Sixty Seven Dollars to me in hand paid or secured to be paid by the said Simeon Eskev the receipt and payment whereof I do hereby acknowledge have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Simeon Eskev his heirs and assigns forever the said tract piece and parcel of Land with its Appurtenances unto the said Simeon Eskev his heirs and as signs forever as fully and absolutely as I the said John L Southern might could or ought to grant bargain sell the same by virtue of the Statute aforesaid and the said Writ of Fieri Facias or otherwise In Witness Whereof I the said John L Southern have hereunto set my hand and seal the fifth day of January in the year of our Lord One thousand eight hundred and Seventy three Signed Sealed and delivered in the presence of
