corner containing 2 R 95 poles (less all that other lot of land
with the buildings thereon commencing at the 3rd corner
of Avenue and Mordica Streets running with Avenue St S
 $79\frac{3}{4} E 152$ ft to corner of 6th & lot thence $816\frac{1}{4} W 113$
ft to a stake thence $87\frac{3}{4} W 152$ ft to Mordica St thence
 $87\frac{3}{4} E 173$ ft with Mordica St to the beginning corner
