Carle's Mill thence along Carle's line S. 4 1/2 E. 10.85 chains to a stake 37 on thence S 59 1/4 W. 3.67 chs to a stake n m thence S 44 1/2 E. 33.11 chs to a stake 37 thence N 61 E. 17.08 chs to a station 5 on thence N 38 1/4 W. 32.90 chs to a stake 37 on thence N 80 1/2 W. 15.00 chs to white oak the beginning. whereas by virtue of a writ of Fieri Facias, issued out of the Court of Common Pleas held for the County of Greenville, dated the nineteenth day of April in the year of our Lord one thousand eight hundred and seventy eight at the suit of William Choice for J. J. Cleveland to me directed, commanding me that of the goods and chattels, lands and tenements of the said Wm J. Taylor his heirs and assigns forever the said tract piece and parcel of land with its appurtenances and all the estate right title and interest which the said Wm J. Stroud of right had of, in and to the same. To have and to hold the said piece parcel and tract of land with its appurtenances unto the said A. M. Taylor his heirs and assigns forever as fully and absolutely as if the said Perry D.
