Drummell of the County of Greenville in the aforesaid State have granted bargained sold and released and by these presents do grant bargain sell and release unto the said B. P. Drummell two tracts or pieces of land in the County of Greenville in the aforesaid State on branch Creek waters of North Fork of Saluda River the first tract contains one hundred and twenty five acres and was conveyed to me by W. C. Goodwin and Co. Wm. C. Giles, W. C. Goodwin and A. Blythe the 7th day of October 1873 reserving to themselves the right to keep up a dam for the use of their mill and for a more particular description of said land and reservations which I now reserve reference will be had to the above named deeds, and I further reserve and retain unto myself a homestead support off of the above named tract of land during my natural life and at my death to be the property of the said B.
