Greenville County in the State aforesaid, in consideration of the sum of Seventy five dollars to me paid by D A Bruce of Greenville County in the State aforesaid, have granted bargained sold and released, and by these presents do grant bargain sell and release unto the said D A Bruce all that tract or parcel of land situate lying and being in the County of Greenville and State aforesaid about five miles from Greenville Court House on the West side of the White Horse road Beginning at a rock corner of B 5<sup>t</sup> S 7<sup>r</sup> E 9.20 chs to west & on said Road thence N 7 W 6.12 chs to Stake & run in said road thence S 7<sup>r</sup> W 1.12 chs to rock & thence S 8<sup>r</sup> E 6.33 chs to the beginning corner containing six acres bee it the same more or less and bounded by lands of said James McPherson said B 5<sup>t</sup> S 7<sup>r</sup> and others Together with all and singular the rights, members hereditaments and appurtenances to the said premises belonging, or in any wise incident or appertaining: To have and to hold all and singular the premises before mentioned unto the said D A Bruce his heirs and assigns forever, and I do hereby bind myself my heirs executors and administrators, to warrant and forever defend all and singular the said premises unto the said D A Bruce his heirs and assigns, against me and my heirs and every other person or persons lawfully claiming, or to claim the same or any part thereof.
