Now know all men, that I the said Perry D Gilreath, Sheriff of Greenville County, in consideration of the premises, and also in consideration of the sum of Eight hundred and five Dollars paid me by the said Perry F Cox, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant bargain, sell and release unto the said Perry F Cox and his heirs and assigns, all that tract of land, situate lying and being in the County and State aforesaid on Reedy River, adjoining lands of John Adams, James Belmore and others, sold as tract No 4 of the real estate of James Love deceased, and known as the Mayfield tract containing Two hundred and thirty acres more or less, together with all and singular the rights, members, hereditaments and appurtenances whatsoever, to the said tract of land belonging, or in anywise appertaining, and the reversions and remainders, rents, issues and profits thereof, and also all the estate, right title, interest, power, possession, property, benefit, claim, and demand whatsoever, both at law and in equity, of the said William B Locke, Administrator with will annexed, and sole Legatee of M J Locke deceased, and of all the parties to the said suit, and of all other persons rightfully claiming or to claim the same or any part thereof, by, from or under them, or either of them, To have and to hold the said tract of land with its hereditaments, privileges and appurtenances unto the said Perry F Cox, his heirs and assigns
