Greenville in County and State aforesaid and on the North East
corner of my lands in said City fronting on West Street, together
two hundred and eighty six feet and on a cross Street one
hundred and sixty five feet, and adjoining lots represented on plat
as Nos 4, 5, 6 and 7 and shown on plat as nos 7 and 8, Together with
all and singular the rights members hereditaments and appurtenan-
ces to said premises belonging or in any wise incident or app-
ertaining, To have and to hold all and singular the premises
before mentioned, unto the said R M Pickett his heirs and
assigns forever. And I do hereby bind myself my heirs executors
and administrators, to warrant and forever defend all and
singular the said premises unto the said R M Pickett his heirs
and assigns, against myself my heirs and every other person
whomsoever lawfully claiming or to claim the same or any part
thereof

granted, aliened and released and by these presents do give grant
alien and release unto said heirs of said Adeline Byrd of County
and State aforesaid all those lots of land, lying in the City of Greenville in
County and State aforesaid, North West corner of my land fronting on
West Street and bounded by William Sims and by lots No 1, 2
and 9 and shown on plat as lots No 10 and 11. Together with all
and singular the rights members hereditaments and appurtenances
to said premises belonging or in any wise incidental or appurtenances
to said premises before mentioned unto
the said heirs their heirs and assigns forever, Provided that said
lots or any part thereof shall not be sold till the youngest
heir comes of lawful age, and I do hereby bind myself my heirs
executors and administrators to warrant and forever defend all and
