Known all men by these presents that I Wesley

Curry of the State and County aforesaid and being sound in mind and having a disposition to make a division of my real Estate between all of my children I now make a deed of gift unto my daughter Rachel Curry of a certain piece or parcel of land lying on the waters of Long branch a tributary of Evers River and situated in Greenville Co. S. C. and bounded by lands of William Bull Nesbitt and others commencing on stone corner on Nesbitts line running South past school house spring to poplar corner thence up the ditch to poplar spring thence east to fork of road thence with road South past my farmstead

to fork of hill to red oak corner thence east to Hickory corner on G. W. Fowler's line thence with G. W. Fowler's line to poplar corner in head of swamp on Bulls line thence North East to stone corner on Bulls line thence west with Bulls line to red oak thence North with Nesbitts line to Red Oak thence West with Nesbitts line to beginning stone corner. Now in consideration of one dollar paid in hand to me I now make unto my daughter Rachel Curry a deed of gift of all of the above mentioned piece or parcel of land. She shall also have the right to live in my homestead so long as she remains single and if she dies without heirs the above land is not to be sold but equally divided between my remaining children but if at her death she leaves heirs this land is not to be sold for any debt but to remain as it is until the youngest child becomes of age and then sold and equally divided between them. My shop tools timber and every thing belonging thereto is to remain where it is for the use of all my children and not to be sold my lot and well and lot buildings to remain (and not to be cleared) for the use of both my daughters Rachel and Eliza Curry. I reserve the above boundary of land for the support and protection of myself Ellenor Curry my wife so long as either or both of us should live.
