 Waddell for ourselves our heirs executors ad-
 ministrators and assigns owners of the said tract
 of three hundred and twenty three acres of land here-
 inbefore described do hereby covenant promise
 and agree to and with the said Francis S. Pelzer
 and his heirs and assigns that the said Fran-
 cis S. Pelzer his heirs and assigns and any
 person or persons at any time associated with
 him or them owners of the said tract of land
 known as Andersons Mills heretofore described
 shall and may at all times hereafter peaceably
