

3x (at Eliza Edwards corner on James Edwards line)
 thence Westerly thirty one and two third rods to a
 stone 3x thence Southerly twenty five and one
 third rods to a stone 3x thence Easterly thirty
 one and two third rods to a stone 3x thence
 Northerly along Eliza Edwards line twenty
 five and one third rods to the beginning corner,
 and containing five acres more or less bounded
 by lands of James Edwards, Eliza Edwards, and
 the original tract being a portion of a tract of
 land willed to me by Dice Bailey about the
 year one thousand eight hundred and fifty seven
 together with all and singular the right members
 hereditaments and appurtenances to the
 said premises belonging or in any wise
 incident or pertaining. To have and to hold
 all and singular the said premises before men-
 tioned unto the said Thomas E Edwards his
 heirs and assigns forever, and I do hereby
 bind myself my heirs executors and adminis-
 trators to warrant and forever defend all
 and singular the said premises unto the
 said Thomas E Edwards his heirs and assigns
 against me and my heirs, and against
 every other person or persons whosoever
 lawfully claiming, or to claim the same, or
 any part thereof.
