State of South Carolina
Know all men by these
presents: That The Southern
Baptist Theological
Seminary, a corporation under the laws of the
State of Kentucky, and located at Louisville in
said State, in consideration of the sum of One Hun-
dred and Seventy five Dollars, paid by Mittie
Louine Hayne of Greenville County South Carolina, the
receipt whereof is hereby acknowledged, has granted
bargained and sold and by these presents does grant
bargain and sell unto the said Mittie S. Hayne
all that piece parcel strip or lot of land situate
lying and being in the City and County of Greenville
and State of South Carolina, the same being bounded
by Mcbee Avenue (formerly Avenue St) on the South,
by Mcbee Street on the West, by lot of land formerly
the property of Dr O. B. Grimes estate but now owned
by said Mittie S. Hayne on the North and East,
being that portion of the lot known as the "old
Baptist Church Lot" contained between the bounda-
ry lines of said Streets and the boundary line of
the said Mittie S. Hayne's lot.

Together with all and singular the rights, members
hereditaments and appurtenances to the said
premises belonging or in any wise appertaining
To have and to hold all and singular the said
premises unto the said Mittie S. Hayne her heirs
and assigns forever. And the said The Southern
Baptist Theological Seminary does hereby bind
itself and its successors to warrant and forever
defend all and singular the said premises unto
the said Mittie Louine Hayne her heirs and assigns
against it and its successors and any and all
persons whosoever lawfully claiming or to
claim the same or any part thereof.
