Know all men by these presents that W. G. Pearson of Greenville County in the State aforesaid, in consideration of the sum of Fifty (\$50.00) out of the Public School funds for High Land Townships Greenville County South Carolina) to me in hand paid by T. Ballinger, J. J. Mitchell or J. J. Jennings Trustees of Public Schools for said High Land Townships in the State aforesaid, have granted bargained sold and released, and by these presents do grant bargain sell and release unto the said Public School Trustee, T. Ballinger, J. J. Mitchell and J. J. Jennings and their successors, a certain piece parcel or tract of land situated lying and being in the County of Greenville State aforesaid on the West side of the Saluda turn Pike road, it being a part or portion of a tract of land known as the J. H. Donaldson tract and conveyed to me by Alston Glenn said lot or parcel of land lying on the South Waters of South Tyger River beginning on a Stone St in the State or Saluda turn Pike road, running thence northward with said road (13 1/2) thirteen and one half rods to a Stone in said road St; thence S 86 N (C) Six rods to a Stone 34, thence South parallel with said road (13 1/2) thirteen and one half rods to a Stone 34, thence a straight line to the beginning corner to a Stone in said State road 34; containing One half (C) one acre or less. I also grant free privilege of ditch course from a School house erected on said piece of land to the water of a Spring at the foot of the hill or north west corner from said piece or parcel of land known as the W. G. Pearson Spring. So long as said piece or parcel of land and said Spring Public School house that is now on said land and house that may be built in said land hereafter, while said Public School house is in use.
