 bargained, sold and released, and by these presents  
 do grant, bargain, sell and release unto the said  
 J. M. Bowling all that free parcel or tract of land sit-  
 uate lying and being in the County and state aforesaid  
 on Musk Creek, and more or less, as follows, Begin-  
 ning at Persimmon on the Dumcomb Road, thence N 30 E  
 3.50 ch., N 82 E 3.69 ch., N 57 1/2 E 2.87 ch., S 47 1/2 E 1.50 ch., S 8 1/2 W
